Accounting - Opening 2021 and Working on Budgets

Did you know that you do not have to wait until the new year to open your new year in Accounting and begin entering or editing your 2021 budget? That's right!

- You can open a new year at any time, but once you open a new year, you must be careful to make sure you are in the correct year when entering transactions.
- Did you know that you can find printable documents and recorded movies on the <u>New Year Prep</u>
 <u>8 Help</u> website page that guides you through all the steps to open a new year in the different CW
 modules? While the documents still reference 2019, they are still applicable to opening any New
 Year.
- Later, If you are working between years and enter transactions in the 2020 year, you must update beginning balances in the 2021 year.
- If you add a new account to the 2020 year, it will automatically appear in the 2021 year.

So, rather than waiting until January, when most churches are busy, busy, busy, you can open your new year now and start entering or editing your 2021 budgets and work between 2020 and 2021.

We've done our homework. We found one tax filing service that will offer direct deposit, filing tax returns, printing W2s, and printing 1099s. Their cost is \$36/month plus \$4 per employee. This service could easily reach \$500/year.

A major payroll processor charges \$10/month per employee just for their basic service. So at 10-15 employees, fees could reach \$2,000/year.

Church Windows Payroll Helper Pricing Tiers

At Church Windows, we like to keep things simple. This service is an annual, flat rate based on the number of employees:

Payroll

Every year it is a good idea to get a head start on reconciling payroll. This year, if COVID-19 and/or Payroll Protection Wages are a part of this year's payments, it is essential to get a jump on this work.

IRS reporting for W-2s requires that employers report each category of Qualified Sick and Family Leave Wages to employees. The information either needs to go in Box 14; or a separate statement to the employee with the W-2. The messaging the IRS wants employers to use is: "sick leave wages subject to the \$511 per day limit," "sick leave wages subject to the \$200 per day limit," and "emergency family leave wages." If employers were to report this in Box 14 of the W-2, it would give the word "fine-print" a new meaning. Have they looked at that form? The wages and withholdings need to reconcile between the W-2s and the 941 reports for the year. Any deferrals of taxes and the Qualified Sick and Family Leave Wages, along with related health care costs, will likely add hours to the task this year. At least getting that reconciliation done through September 30th before heading into the busy Christmas season will alleviate many January headaches.

Last Quarter

We are in the final quarter of 2020. Here are a few things you might need to review in each module. Since the program is very flexible, you might have other fields or reports you check in addition to these.

- Membership Advancing school grades, advancing groups/classes, and printing an allinformation report for members to check for corrections or changes.
- Donations review Giving Statements and Pledge Reports.
- Accounting review the Balance Sheet and Treasurer's Report.
- Payroll review an informative copy of W2s.

Optional Social Security Tax Withholding 9/1-12/31/2020

On Friday, August 28th, the Treasury Department and IRS issued guidance on the presidential directive to allow employers to defer employees' portion of Social Security withholding tax beginning September 1st, 2020. (This guidance is Notice 2020-65.) While we discourage participation, we have a document that explains how to process this in Church Windows Payroll.
